ART. 1 FINANCIAL REQUIREMENTS

The Art. 3 of the Call for assignment of Financial Aid Benefits A.Y. 2021/2022 – issued by the Management Decree Ref. 89785/2021 dated on May 28th 2021 (hereinafter also "the Call"), is supplemented as follows.

ISEE/ISEEU and **ISPE/ISPEU** limits

Students requesting Financial Aid Benefits (hereinafter also "DSU benefits") should have:

- an ISEE/ISEEU Parificato (issued for the sake of obtaining "benefits for the right to higher education") no higher than € 23.000;
- an ISPE/ISPEU calculated by dividing the ISP value (Assets Status Indicator provided by INPS) by the equivalency scale, no higher than € 50.000.

Regardless of their merit, students whose ISEE/ISEEU Parificato or ISPE/ISPEU exceeds the abovementioned limits will be excluded from the assignment of DSU benefits.

Independent student

A student constitutes an independent family unit from the one of the family of origin when the following requirements are met:

- The student has had a different and separate residence from their family for at least two years starting from the application date, and such a residence is not located in a property owned by their family;
- The student perceives a fiscally declared income derived from an employment relationship or assimilated no lower than € 6.500. Such activities must not be carried out under an individual who is bonded to the student through kindship. If the independent student, basing on their civil status certificate, is cohabiting with another person, the incomes of both people must be considered mandatorily, even if they are not relatives.

If a student is independent, the income is not integrated with the household income.

ART. 2 DSU SCHOLARSHIPS: NUMBER AND VALUE

Art. 13 of the Call is supplemented as follows. There are **4.300** DSU scholarships available, divided up as below:

Students enrolled on the first year of PhD and specialisation programs	10

Income brackets

The income brackets, to determine the DSU Scholarship amount, are determined as follows:

Scholarship amounts based on student's income brackets and geographical origin

The DSU scholarship's amounts, considering both the income brackets and student's geographic origin, are determined as follows:

1 st bracket	€ 2.007,00 + one free meal per day for a total of € 2.719,00
2 nd bracket	€ 1.544,00 + one free meal per day for a total of € 2.256,00
3 rd bracket	€ 1.220,00 + one free meal per day for a total of € 1.932,00

1 st bracket	€ 2.213,00 + one free meal per day for a total of € 2.925,00
2 nd bracket	€ 1.748,00 + one free meal per day for a total of € 2.460,00
3 rd bracket	€ 1.421,00 + one free meal per day for a total of € 2.133,00

Away from home	student housed in Politecnico di Milano residences
1 st bracket	€ 2.163,00 + housing + one free meal per day for a total of € 5.278,00
2 nd bracket	€ 1.577,00 + housing + one free meal per day for a total of € 4.692,00

Students enrolled in the additional term of all courses and students enrolled in the first year of Master of Science courses starting from the second term, will be assigned a scholarship reduced by 50%.

Students with certified disability of 66% or higher have the right to be assigned the scholarship, even if this exceeds the number of available scholarships. The annual amount may be increased as follows:

€ 2.821 for local students
€ 4.014 for commuter students
€ 7.353 for away-from-home students

ART. 3 CATERING SERVICE DEDUCTION

Art. 19 of the Call is supplemented as follows: a deduction equal to € 712.00 will be made from the amount of the DSU scholarship. A 50% will be deducted from the first instalment of DSU scholarship, while the remaining 50% will be deducted from the second instalment.

Assigned students, enrolled in the Online School of Engineering of Computing Systems may request for the abovementioned deduction not to be made. This request should be presented exclusively through the email¹ address indicated on www.polimi.it/diritto-allo-studio. By making such a request, they will no longer benefit from catering in the way in which such a service is disciplined by Art. 19 of the Call

ART. 4 DEDUCTION FOR STUDENTS HOUSED IN POLITECNICO'S RESIDENCES

Art. 29 of the Call is supplemented as follows: a **deduction** equal to € **2.403,00** will be made from the amount of the scholarship for student housed at Politecnico di Milano residences.

ART. 5 MERIT BASED REQUIREMENTS: students enrolled in the FIRST YEAR

Art. 4.2 of the Call is supplemented as follows: in implementation of art. 6, paragraph 8, of Ministerial Decree dated on April 9th 2011 the extra ECTS (extra credits or out of study plan), namely those which do not contribute to the achievement of the degree, will not be considered for the purpose of the merit requirement.

ART. 6 MERIT BASED REQUIREMENTS: students enrolled in SUBSEQUENT YEARS

Art. 5 of the Call is supplemented as follows: in implementation of art. 6, paragraph 8, of Ministerial Decree dated on April 9th 2011 the extra ECTS (extra credits or out of study plan), namely those which do not contribute to the achievement of the degree, will not be considered for the purpose of the merit requirement.

ART. 6 REFERENCE

The other regulations contained in the Call issued by Management Decree Ref. 89785/2021 dated on May 28th 2021 remain unaffected.
